

**DESTINATION → Terracotta**, **brick**, **natural stone and industrial cement floors**. Do not apply on surfaces that are not resistant or sensitive to solvents.

**PROPERTIES CS** is a product with an **energetic de-waxing action** based on **specific solvents and emulsifiers**, designed to address the problems of **removing various treatments** (acrylic or paste finishing waxes, waxy, acryl-wax or polymeric treatments), of uncertain nature and / or of particular resistance, not removable with **BASICO** or with standard alkaline detergents.

**USE** Before any intervention the flooring must be perfectly dry. Apply the pure product with a brush or rag starting from the back wall of the room towards the door and treating small surfaces at a time (3-4 square meters). Allow the product to work for about 10 minutes, then brush the surface with an abrasive pad and / or a single disc machine with a brown or black abrasive disc, wetting thoroughly with BASICO diluted in a 50% concentration in water (see the technical data sheet). When the goal is achieved, remove the residual solvent and resins using a wet vacuum cleaner and / or absorbent paper, in order to prevent it from settling again. If further residues are present and evident, repeat the operations described above, otherwise rinse thoroughly with clean water and carry out the subsequent neutralization wash with ACIDO (see the technical data sheet). The success of the subsequent treatment is determined by a perfect cleaning, a good rinse as well as the complete drying of the floor (about 5-6 days). Establish through a preliminary test the resistance of the support to the product as well as the right application methodology to be used, in order to avoid possible undesired effects.

YIELD → As an indication only, 5-10 m<sup>2</sup>/I of product.
