## **RP 108**

# Neutral detergent for natural stones also of monumental interest







**DESTINATION** → **Natural stones and artefacts** of historical, artistic and / or monumental interest. Delicate, polished and / or leaded stones.

**PROPERTIES** → **Neutral detergent** formulated on the indication of the **AB57** formula of the **Istituto Centrale del Restauro**, based on **ammonium bicarbonate**, **EDTA** and **quaternary ammonium salts**, **special biodegradable neutral surfactants** and used for the selective and delicate removal of organic and inorganic dirt (smog, soot, guano, etc.). The product does not affect the original aging patina of the supports and **does not alter their appearance**, making it particularly suitable for cleaning operations in the **conservative restoration** of stones and artistic and monumental artefacts.

**USE** Apply **RP 108 pure**, using a **synthetic fiber brush**, if necessary assisting the action with brushes and / or **abrasive pads** (obviously if the delicacy of the support allows it). Leave the product to act for about 15/30 minutes, checking that the surface remains uniformly wet from the product and then **rinse thoroughly with water**, preferably under pressure. Wait for the substrate to dry in order to evaluate the effectiveness of the intervention. If necessary, repeat the operation. On surfaces that have particularly tenacious and / or layered dirt, the product can be applied with the **wrap technique**. This procedure involves **mixing the pure product with aggregates** (cellulose, paper pulp, sepiolite, i.a.) and distributing the obtained mixture, making it adhere perfectly to the support and, subsequently, covering it with films in order to prevent rapid drying. Let it act **from a minimum of 2 to a maximum of 24 hours**, then **rinse thoroughly with water**. Wait for the substrate to dry in order to evaluate the effectiveness of the intervention. Repeat the operation if necessary. Establish the right application method by preliminary test, also in order to avoid possible side effects.

YIELD → As an indicative purpose 4-8 m²/lt of product.

Formulated on indication of formula AB57 of the Central Institute of Restoration, based on ammonium bicarbonate, EDTA, quaternary ammonium salts and specific biodegradable neutral surfactants, it must be able to be used for the selective and delicate removal of organic and inorganic dirt (smog, soot, guano, etc.) without affecting the original aging patina of the substrates. It must not contain corrosive substances such as acids or alkalis. The product must also be capable of being used with the wrap technique and must be accompanied by a 16-section safety sheet as required by current legislation.
