# **SMACCHIATORE RAPIDO**



Spray stain remover for floorings and porous materials such as cotto, bricks, stone and concrete





**DESTINATION** → Floorings and surfaces in cotto, bricks, clinker, natural stone, industrial cements, also polished. Do not apply on surfaces that are not resistant and / or sensitive to solvents.

**PROPERTIES** → SMACCHIATORE RAPIDO is a stain remover in spray can, formulated for the elimination of greasy and oily stains absorbed or penetrated deep into the porosity of absorbent or polished surfaces, not removable with common detergents.

The combined action of solvents and diatomaceous earth makes it possible to extract any residual oil, greasy stains, etc., even old or deeply penetrated, without leaving residues or halos. SMACCHIATORE RAPIDO can be used both on untreated and treated surfaces: in the latter case, once the stain has been cleaned, it will be necessary to restore the protective treatment.

USE → Apply the product only on dry surfaces, free from other types of dirt. SMACCHIATORE RAPIDO is ready for use. Shake the can well and spray the product from a distance of 15/20 cm, keeping the can tilted 45 degress above the stain, trying to spray the product in a spiral pattern in order to ensure an uniform and even coat. Apply an amount necessary to create a slight stratification over the stain (at least 1/2 mm thick) according to the difficult of the stain. Then wait until the white powder is completely dry (at least 30/40 minutes). Carefully vacuum the residual powder, if necessary rub the affected area with a wet sponge to remove all powder residues, and evaluate the effectiveness of the intervention. Repeat the operation if the stain has not been completely eliminated or superficial halos remain. Carry out preliminary tests on the surface to be cleaned in order to avoid possible unwanted effects.

N.B: on very absorbent materials or if the stains are old, it will be necessary to apply a thicker layer of product and possibly take several subsequent applications to obtain a good final result.

YIELD → As an indication, 10-15 applications per can. Yield may vary based on the material. Up to 15 applications can be carried out on smooth, treated or slightly porous substrates, with stains of about 6-7 mm in diameter. On extremely absorbent substrates (e.g. cotto or bricks) that are not treated or protected, the yield can be reduced by up to 10 applications per can.

SPECIFICATIONS → Spray stain remover for the removal of greasy and oily stains absorbed in the porosity of surfaces and / or floorings in cotto, bricks, clinker, natural stone and industrial cements (such as SMACCHIATORE RAPIDO by CIR). It must allow to extract any oily residue, even old or deeply penetrated, without leaving residues or halos. The product must be accompanied by a 16-section safety data sheet as required by legislation in force.

- → Product intended for professional use.
- → Operating temperatures from + 5 ° C to + 35 ° C
- → Do not apply in conditions of high humidity, impending rain and in full sun conditions.
