**DESTINATION** ➔ Drain cleaner for **sinks, toilets, bidets, showers**, etc.

**PROPERTIES** ➔ Product intended for **professional use**. **VORTICE PLUS** is a **concentrated acid-based drain cleaner** (based on sulfuric acid).

**VORTICE PLUS** is a highly effective solution to **solve the problem of clogging of drains and domestic pipes**. The product works **by dissolving inorganic cloggings** such as food, food fats, soaps, fabrics, residues of clothing and underwear, eliminating everything that prevents the normal flow of water in the pipes. **Also suitable for industrial drains**. It does not damage gaskets and pipes in plastic, PVC, rubber. Pay attention to avoid contact with taps and other metal surfaces near the drains as well as surrounding surfaces in marble, ceramics and natural stone.

**USE** ➔ **VORTICE PLUS** is a **concentrated product that does not require further dilution in water**. To avoid contact with taps and drain grates, **it's advisable to use a funnel to pour the product directly into the pipes**. Remove any excess water and start pouring the product, **at least 200-300 ml**: let it act **for about 10/15 minutes**, increasing the amount in the case of particularly wide pipes. Finally, **start pouring half a liter of water down the drain** to help eliminate the product and dissolved residues. In the case of application on a toilet, **it's advisable to use a pipe funnel to reach the siphon**, in order to pour the product directly on the clog and allow a more effective action. In this case, **the amount to be used is between 500 and 1,000 ml**.

**YIELD** ➔ As an indication, **5-6 doses per liter** of product for small drains, **1 dose per liter** of product for a toilet drain.
